China Sunsine completes construction of MBTS plant

Singapore, 29 June 2009 - The Directors of China Sunsine Chemical Holdings Ltd. ("The Group" or "China Sunsine"), a specialty rubber chemicals producer and probably the largest accelerators producer in PRC and the World, are pleased to announce that the Group has completed the construction of its 7,000-ton accelerator MBTS plant at its Facility 2.

It has since commenced trial production of both accelerators - MBTS and MBTS (medical grade) - that are to be produced in this plant. It is estimated that the trial production may take a month or so depending on the results of its testing.

The completion of this plant is not expected to have any significant impact on revenue and profit in the current financial year.

The Group expects a potential demand of up to 4,000 tons a year for this MBTS (medical grade) eventually, and this plant should be able to meet that demand.

"We have already received several initial small orders this month from several customers serving the pharmaceutical sector for the production of antibiotics medicine. Due to the additional processing for MBTS (medical grade), customers are willing to pay a higher price for it. We continue to listen to customers' feedback and suggestions on how we can serve them better.
