Singapore, 3 July 2009 - The Directors of China Sunsine Chemical Holdings Ltd. With the establishment of the RMAC, we now have a dedicated team to monitor the Group's risks, and align it to our business strategy. This team shall stay focus on the various kinds of risks faced by the Group, and actively manage them in accordance with the Board's directions," added Chairman Xu.
