China Sunsine completes prestigious client list of top 10 major tyre manufacturers

• Successful accreditation and trial orders from Continental AG

Singapore, 4 December 2007 – **China Sunsine Chemical Holdings Limited** ("China Sunsine" or "The Group" or "尚舜化工"), one of the world's largest producers of rubber accelerators, has received trial orders from German tyre manufacturing giant Continental AG's ("Continental") operations in Malaysia and South Africa. Prior to this, Continental was the only major tyre manufacturer not on China Sunsine's client list. As such, China Sunsine's client list now includes all of the global top 10 tyre manufacturers.

Major international tyre manufacturers typically conduct an accreditation process lasting 6-12 months before placing trial orders from chemical suppliers. The trial orders for Continental's Malaysian plant are for 10 tons of CBS and 10 tons of TBBS, while the trial orders for its South African plant are for 40 tons of DCBS and 40 tons of DPG. China Sunsine's products are essential chemicals for the production of rubber tyres and rubber products. Once the trial orders have been received satisfactorily, Continental is expected to increase its sales orders next year.

Continental, a German conglomerate, is the world's 4th largest tyre manufacturer¹ best known for its winter tyres and high-performance summer tyres. In 2006, Continental produced approximately 113.3 million tyres worldwide². Its Malaysian plants and South African plant contributed about 4.8 million and 2.4 million tyres respectively. Tyre manufacturing is estimated to require 1.7 tonnes of rubber accelerators for every 100 tonnes of rubber used. Based on this figure, the potential demand for rubber accelerators from these plants is 1,100 tonnes³.

The announcement is the third in a series of good news. Last month, **China Sunsine** announced that it would be expanding its service coverage to Pirelli Tyres (world no. 5 tyre manufacturer) to include its Brazil and Turkey operations. In the same month, **China Sunsine** also announced that it would be supplying Michelin (world no. 2 tyre manufacturer) with one additional high-volume product, the rubber accelerator CBS.

To cater to the strong demand, **China Sunsine** plans to expand capacity organically from 32,000 tonnes at present to 62,000 tonnes by the end of 2008.
