# **China Sunsine Secures Government’s Approval for the Trial-run of 30,000-ton TBBS Expansion Project**

**SINGAPORE – 14 January 2019 – China Sunsine Chemical Holdings Ltd** (“**China Sunsine**” or the “**Group**”), a specialty rubber chemicals producer and global leader in the production and supply of rubber accelerators, is pleased to announce that its wholly owned subsidiary, Shandong Sunsine Chemical Co., Ltd (“**Shandong Sunsine**”), has, on 10 January 2019, received the Government’s approval for the trial run of its 30,000-ton accelerator TBBS expansion project.

This fully automated 30,000-ton TBBS expansion project is split into 2 phases. Shandong Sunsine has completed the Phase 1 10,000-ton production line. Upon successful completion of the trial run, commercial production will commence. The commercial production of Phase 1 TBBS will increase the Group’s capacity for Accelerator from 87,000 tons to 97,000 tons per annum, while the Group’s total capacity will increase from 162,000 tons to 172,000 tons per annum.

China Sunsine retains its market leadership position as the world’s largest Accelerator producer, as well as China’s largest Insoluble Sulphur (“**IS**”) producer. With this increase in capacity, its market position is further strengthened. These expansion projects, including 10,000 tons IS expansion project which were approved for trial-run on 21 November 2018, will become new growth drivers for the Group.
