Shandong Sunsine Changes its Legal Representative

The Board of Directors of China Sunsine Chemical Holdings Ltd. (the "**Company**", together with its subsidiaries collectively, the "**Group**") wishes to inform that its wholly owned subsidiary, Shandong Sunsine Chemical Co., Ltd ("**Shandong Sunsine**"), has, on 11 July 2025, changed its legal representative from Mr Xu Jun to Mr Zhang Shun in order to comply with a Notice issued by the Department of Emergency Administration of Shandong Province, which requires that the main responsible personnel for all the chemical manufacturing companies generating dangerous chemicals during their production process must possess safety production knowledge and management capabilities that are suitable for the production and business activities they engage in; obtain a certificate of qualification for safety production knowledge; have a college degree or above in chemical engineering; and obtain practical experience.

Mr Xu Jun holds a Diploma in Business Administration from Jining University of Technology, and therefore does not fulfill the strict requirements of the Notice on educational qualifications. In view of Mr Zhang Shun (Group's Deputy General Manager in charge of production and safety) having met all the statutory requirements, the board of directors ("**Board**") of Shandong Sunsine has resolved to appoint Mr Zhang Shun as the legal representative of Shandong Sunsine, in place of Mr Xu Jun.

Save for the above, there are no other changes to the roles and composition of the Board of Shandong Sunsine.
